Dear Supporter,

In 2022 NOMAS experienced the typical growing pains of a young nonprofit. We tried, tried again and kept trying at grant writing. We lost our office space in four locations. We suffered new heartbreak over the pain of those fleeing Ukraine and those silenced in Afghanistan. We puzzled over the problems posed by ever-increasing visa processing times.

However, like a teenager blossoming out of adolescence, NOMAS has emerged from 2022 with greater experience and independence, much thanks to you. It takes a village to raise a child, and it takes a strong network of supporters to grow a nonprofit.

In the past year you helped NOMAS:

- Succeed at grant writing! and diversify its funding base
- Hold monthly clinics online and in six locations in Utah and Idaho
- Begin serving Ukrainians and Afghans
- Develop tech tools to prepare visa applications more efficiently

At the start of 2022 I would have compared NOMAS to a child that depended on me for everything. At the close, I feel like NOMAS has emerged to stand on its own, taking its place among its peers. Some major steps have been:

- Training leaders including
 - two new lawyers hired as associate directors
 - five non lawyers accredited to provide legal services
- Strengthening meaningful connections with local partners
- Providing legal services worth \$373,400 on a \$224,602 budget
- Serving nearly 1,000 individuals and their families

NOMAS was especially excited to receive its first donation from a law firm. The donation from the Utah firm of Ray, Quinney, & Nebeker, kickstarted plans for new bite-sized volunteer opportunities that will allow more lawyers to engage in the mission of NOMAS in 2023.

I look forward to watching its continued growth from the front-row. Come join us on a Thursday night as a clinic volunteer or financial donor. I'll have a seat saved just for you!


